## Introductions

Eva Samalea, new Shelter Cluster Coordinator for Cabo Delgado and Nampula, has joined the mission in Mozambique the 28<sup>th</sup> September. Bilateral introductions meetings have been done with different partners, and this first Shelter Cluster Meeting is an opportunity for Eva to understand better the dinamics and the context.

## Follow up from the previous Shelter Cluster meeting

- Distributions plans for September has changed considering the new influx of IDPs and the situation worsening in some areas which has limited the access (Palma, Ibo Island, Ancuabe)
- Mecufi and Metuge assessment pending to be shared from Care to be updated in the next meeting.

Nanjua assessment about the reconstruction status and recommendations pending to be shared from AeA – updates to be shared in the next meeting.

## General Shelter Cluster updates

- Agenda for HNO and HRP with main deadlines shared first deadline on Friday 9<sup>th:</sup> PIN
- Eva will contact the partners for further information during the processes and will share the tools as soon as available.
- DTM updated data: 329,809 IDPs (Cabo Delgado, Napula and Niassa)
- Ratio to be used between IDPs and Host Families should be used to consider PIN: 1:1,5 (IDPs:HF)
- List of indicators to be selected for the PIN to be shared with the partners, and based on the feedback, 3 will be selected.

## Response plan for Metuge

- Information about resources available for Metuge to be shared so Shelter Cluster Coordination can coordinate with other Clusters and start the distributions as soon as the verification exercise is finished.
- Mosquito nets are not available within the Shelter Cluster partners, but it is being coordinated with other Clusters.

#### Pipeline materials for Shelter/NFI

- Tracking tool for stock availability in Google Drive is not updated to be updated on a weekly basis (if there is any update) by the partners.
- Storages locations need to be specified in the tool.
- NFI WASH related items need to be closely coordinated with WASH Cluster, by the Shelter Cluster partners to include those items on the stocks.
- Availability of Mosquito Nets to check with Jose from UNICEF.
- Templates for Pipeline materials presented to be shared with the partners via email.

## Updates from the partners

 Cáritas/CRS: Shelter/WASH project presented to the Government which requests to focus on 1 location, to assist host families with rehabilitation materials, and IDPs with emergency shelter in resettlement area selected by the Government. CRS/Cáritas technical team can support with land demarcation and technical advise on the conditions of the land.
